# SUPPORTING ESSENTIAL SERVICES

## SAN DIEGO COUNTY CHILDCARE PROVIDER GRANT PROGRAM

On August 4, 2020 the San Diego County Board of Supervisors unanimously voted to distribute \$25 million of CARES Act funding to child care providers in San Diego County who are offering essential services to local families during the COVID-19 pandemic. Funds were earmarked to help support staffing, supplies, mortgage and rental assistance, business resilience, and capital improvements for outdoor areas. Licensed Family Child Care Homes, licensed Child Care Centers, and legally license exempt Child Care Centers were all eligible for funding.

The County partnered with The San Diego Foundation, YMCA of San Diego County Childcare Resource Service, and Child Development Associates to manage the application, verification, and grantmaking process. The following data summarizes YMCA CRS's efforts as of December 1, 2020.

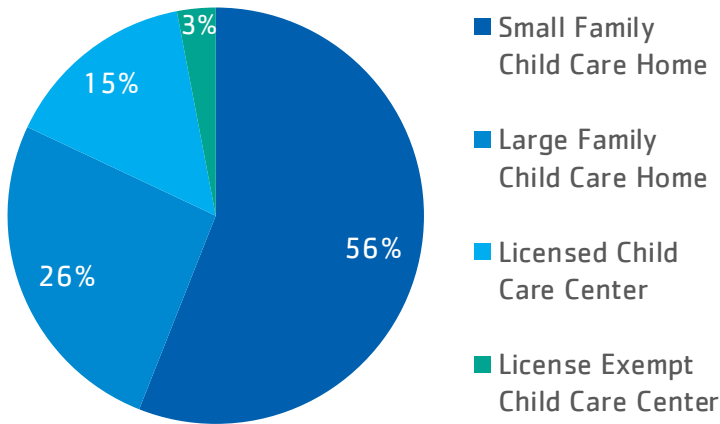
### APPLICANTS



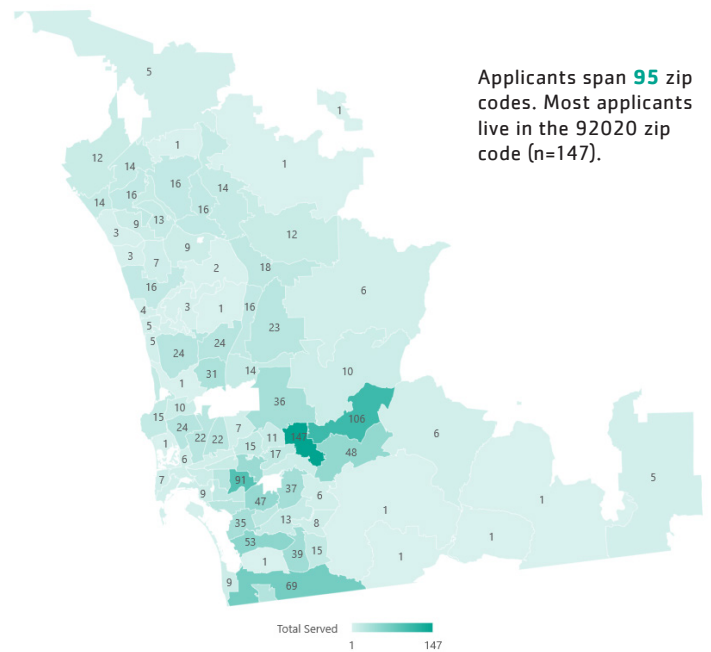
#### TOTAL APPLICANTS

1,648 applications were received. Of those, 1,554 applied for one license, 82 applied for two licenses, and 12 applied for three licenses. There were 1,599 total unique provider applicants.

#### APPLICANT TYPE OF CARE



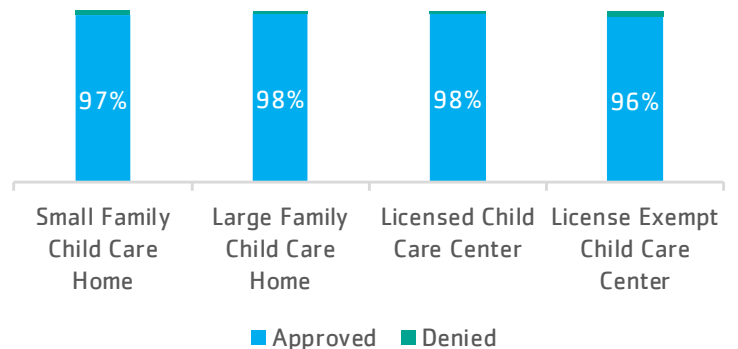
#### WHERE APPLICANTS PROVIDE SERVICES



#### APPROVAL RATE

95% of all applications were approved. Of those that were *not* approved, 45% are an ineligible type of provider, 4% live outside the county, 2% did not meet the deadline, 35% did not provide requested documentation, and 14% had unverifiable business information.

## TOTAL AWARDS

Of the **1,648** applications received, **1,568** were approved. **1,481** were approved for one license, **39** were approved for two licenses, and **3** were approved for three licenses. There were **1,523** total unique providers approved for a grant.

## AWARDS GRANTED BY TYPE OF CARE

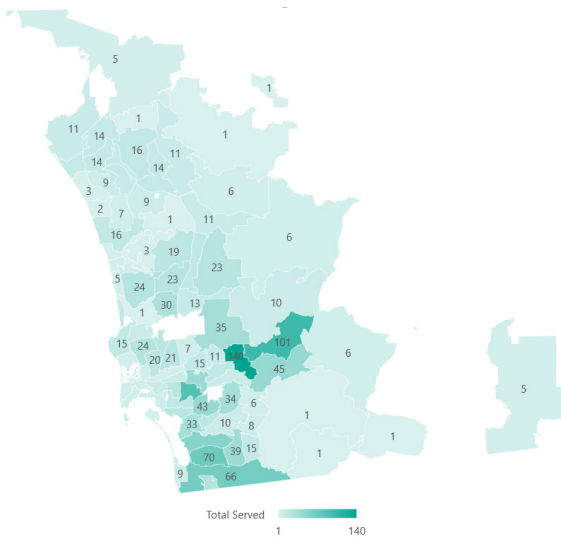


- Small Family Child Care Home

## WHERE AWARDEES PROVIDE SERVICES



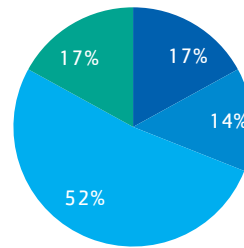
Awardees span **92** zip codes. Most awardees live in the 92020 zip code (n=140).



## TOTAL CHILDREN

**41,530** children are cared for by all applicants. Of those approved, **39,889** children are cared for.

## PROVIDER LANGUAGE

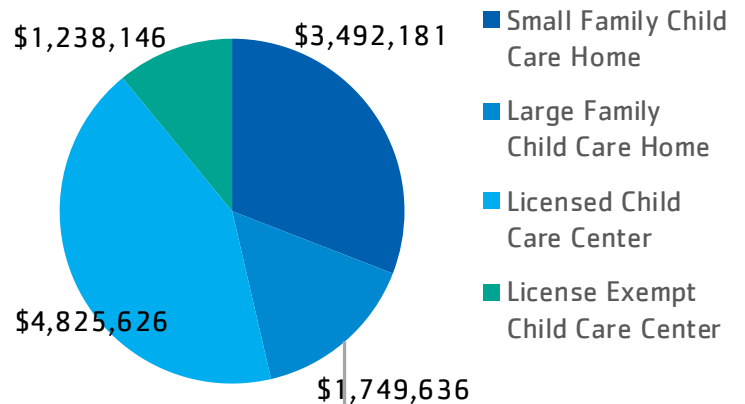
**2%** of all approved applicants are Arabic speaking, **84%** are English speaking, **13%** are Spanish speaking, and **1%** speak other languages.



## AWARD AMOUNTS

Large Family Child Care Homes were awarded a flat rate of **\$4,452** while Small Family Child Care Homes were awarded a flat rate of **\$4,123**. Child Care Centers were awarded **\$235** per child served while License Exempt Child Care Centers were awarded **\$182** per child served. Only non-subsidized spots were counted towards total children served.
